**I. Call to Order** Vice President Heidi Voorhees called the meeting to order at 7:15 pm.

**II. Order of Business** Holly Berman moved to adopt the order of business. Bobbie Friedman seconded. Motion passed.

**III. Adoption of Rules** It was agreed that the meeting would be conducted according to Roberts Rules of Order. Clarice Stetter will serve as parliamentarian.

**IV. Acceptance of 2006 Annual Meeting Minutes** Judy Mandel moved to accept the minutes, and Libby Bankoff seconded the motion. Motion passed.

**V. Appointment of Committee to Approve Minutes of 2007 Annual Meeting** Deena Mitchell and Dale Cohodes were appointed.

**VI. President's Remarks**

Vice-President Heidi Voorhees spoke on the theme of relevance, which is a current topic of discussion at all levels of the League. Our monthly board meetings are lively, substantive, and relevant. One of highlights of our year was the Tenth District Congressional race debate. The Tenth District Leagues held what turned out to be the only debate of the two candidates in this election. It was very well attended and received major press coverage. We struggle with ways to handle debates in the future, and have talked about pursuing empty chair debates.

The league has engaged in many other timely and relevant activities. Vice-President Georgia Gebhardt studied electronic voting, a major issue in elections today. We talked about the administration of Cook County government, which is important for fair elections, among other things. Our immigration consensus meeting, which addressed a timely topic, was well-attended. In summary, all the work our League performs is very relevant, and we look forward to another exciting year, including the program *Our Climate Matters* led by Libby Bankoff.

**VII. Treasurer's Report** Treasurer Marylin Weber reported that LWV-Wilmette has had a good financial year, with \$16,998.25 in cash going into new fiscal year. Revenues were \$822 under expenses, even with 14 more members, because of delayed payment for attendance at the 2005 national convention and higher PMPs. Ph-nathon revenue, and shared telephone bill revenue, are still outstanding. . The Education Fund is sound this year, with expenditures \$2600 less than revenues. This year PMPs were paid from the Operating Budget, not from the Education Fund.

**VIII. Budget Presentation** The 2007-08 Budget, which was mailed to all members as part of the April 2007 newsletter, shows a projected \$200 revenue deficit in the General Fund. This is due in part to projected expenses for the national convention in June, a State of the Village program this year, and increasing PMP rates. The newsletter will be distributed electronically to those willing, which may save money unless the savings is offset by lost ad sales. Yearbook updates will be much cheaper than this past year because only replacement pages will be sent out. The Education Fund budget includes \$1500 in start-up funds for *Our Climate Matters*. Holly Berman moved, and Judy Mandel seconded, a motion to adopt the budget. Motion carried.

**IX. Nominating Committee Report** Holly Berman, Nominating Committee Chair, presented the slate on behalf of the rest of the committee, Mari Terman and Clarice Stetter. Other Board members were consulted as well. Holly Berman, Debi Chess-Mabie, Kent Brown and Jane Jacobsen-Brown are retiring from the Board. The primary concern with the slate is that there is no Voter Services nominee. No member would accept that position because it is nonpartisan and we are entering a Presidential election cycle. This will have to be addressed by the Board. It was noted that the Bulletin position will be an on Board position again. There are no off-Board positions next year. Concern was raised about the difficulty in recruiting Board members, and it was suggested that we begin recruiting earlier next year. Marvin Miller moved to approve the slate of nominees as presented. Marylin Weber seconded. The motion carried. Next year's nominating committee will be appointed at an upcoming Board meeting.

## **X. Program Report**

**a. Our Climate Matters** Chair Libby Bankoff explained that this project stems from a Board decision last year to focus on energy issues in 2007. The committee has been working since January to formulate the outlines of the project. The goal is to host a series of educational programs, spread out over several days in October 2007, each designed to focus on a specific aspect of the global warming problem. The series likely will include speakers, panel discussions, town hall meetings, neighborhood coffees, book group discussions, and film festivals, to be held at venues covering a wide area of the North Shore. All other North Shore leagues will cosponsor the program. The committee hopes to attract big-name speakers to generate interest in the program. *Our Climate Matters* programs will finish before the start of the Chicago Humanities Festival, which will have a related theme, *Climate of Concern*, this year.

**b. Student Government** Ellen Falkof reported that the program was very successful this year, with 75 participants from four local junior high schools. Village President Chris Canning spoke at the breakfast. One of the challenges going forward is how to involve more students from WJHS, by far the largest participating school. Currently each school is assigned one local board, and as a result only 25 percent of WJHS students who sign up can participate. It is also becoming more difficult to schedule workshops with Board members prior to meetings because of the ISAT schedule. Possible solutions will be discussed with junior high officials.

**c. Voter Service** Deena Mitchell reported the League sponsored its first ever voter registration drive at New Trier this fall. The project was very successful and will be repeated next year in the spring semester, when more students will be 18. The League sponsored three candidate debates in the fall and prepared the Voter Services Guide for the spring elections. The Village Trustees debate this spring was not well attended. Marvin Miller suggested that the League respond to a recent Pioneer Press letter to the editor complaining about the presence of the League Voter Services Guide at a polling place. We will get a clarification from Cook County on its policy related to that issue. Heidi Voorhees reported that we had a Women's History Luncheon in March and a book event in August. Both will be held again next year.

## XI. New Business

**a. Student Government** Discussed above.

**b. Future of Organization** Vice-President Voorhees initiated a discussion of the future of the Wilmette League. This issue is a concern because the League is having trouble getting members to assume leadership positions, even with increased membership this year. Other area leagues have similar issues, and the Executive Board has discussed regional merging as a possible solution. Members suggested other approaches such as trying to increase membership through a membership committee, new member events, and high visibility programs such as book discussions. The problem may stem in part from perceptions of the League as too process-oriented and too liberal, and also could be generational. It was agreed that the issue is serious and needs to be addressed, and merger should be considered a real option.

The next meeting of the Board will be on June 9, 2007 at Marylin Weber's house.

**XII. Adjournment** Bobbie Friedman moved, and Marylin Weber seconded, a motion for adjournment. Motion carried and the meeting adjourned at 8:50 pm.
