
Who We Are

The Big Picture

Our current tax system is unfair and inadequate, allowing millionaires and billionaires to avoid paying their fair share of taxes while underfunding the critical public services we all depend on.

Fair Tax reform means anyone who makes \$250,000 a year or less gets a tax cut or pays no more than they do now – that's 97% of Illinoisans (and about 60% of Wilmette taxpayers). The Fair Tax also raises \$3 billion that can be used to fund education, health care, jobs, human services, and infrastructure in our communities.



What's Wrong With Our Current Tax System?



Unlike Most States and Federal Government, Illinois Income Tax Rates Are Not Based on Ability to Pay

- Illinois' constitution requires all taxpayers to pay the same income rate (currently 4.95%), regardless of a family's income and ability to pay
- The result is a family making \$25,000 and a family making \$25
 million pay the same income tax rate that's unfair
- Because of this constitutional requirement, we cannot modernize our tax system so higher incomes pay higher rates and lower incomes pay lower rates


Our Current Tax System Is Fundamentally Unfair


This old way of taxing income in Illinois is unfair and inadequate:


- It is unfair because it falls too heavily on the middle class and those struggling to get there
- It is inadequate because it underfunds critical services, pushing up property taxes and forcing cuts to schools, public services and jobs



The disparity in income growth is vast.










The Problem: Illinois' Tax System is Unfair


Working People Pay More of Their Income in Taxes Than the Wealthy

Our Current Tax System Fails to Properly Fund Education, Pushing Property Taxes Up

- A chief responsibility of our state tax system is to fund public education
- Traditionally, only about a quarter of education funding has come from the state government in Illinois - the national average is nearly double
- This forces local governments to shoulder more of the education burden
- The main mechanism for local governments to fund education is property taxes, resulting in higher property taxes for our middle-class families



Our Public Services Have Suffered Too Many Cuts

Under previous administrations' cuts:

- Mental health treatment facilities and domestic violence shelters were forced to close
- Health care providers struggled to serve patients
- 40,000 low-income children could not receive the childcare they needed
- 7,500 higher education jobs were lost

What Is the Fair Tax?



Fair Tax reform means higher-income earners pay a higher tax rate while lower and middle-income earners pay a lower tax rate.

It is fundamentally fair because it ensures the wealthy pay their share while lifting the burden off middle and working-class families.



Majority of States Have a Fair Tax System

- The majority of states use a fair tax system, including the majority of our neighboring states
- The federal government uses a fair tax system
- We are one of only four states to mandate a flat tax in our state constitution

The "Fair Tax" Generates Needed Revenue, Shifts Tax Burden to the Top and has Rates within Midwest Range

Has a top rate of 7.99%—compared to:

- Minnesota —9.85%
- lowa 8.53%
- Wisconsin 7.65%

Fair Tax Reform Also Includes Additional Tax Cuts for Our Families

- Expands the property tax
 credit from 5% to 6%
- Implements a child tax credit of \$100 per child for households making under \$100,000

How Do We Pass the Fair Tax?



What it takes to win...

 50%+1 of ALL voters who cast a ballot in the election

OR

 60% of people who cast a YES or NO vote on the ballot question

FAIR TAX AND RACE EQUITY GUIDANCE ON DISCUSSING HOW THE FAIR TAX ADVANCES RACIAL EQUITY.

 The tax code is both a symptom of and instrument of systemic racism. Racial inequit furthered by Illinois' unfair tax system where low income and working people now p as much as wealthy people as a share of their income. This inadequate tax system fo harmful cuts to state and local governments while pushing up property taxes, which causes the tax burden to fall more heavily on Black and Latinx homeowners.



Our Small Businesses Need The Fair Tax

There's been a lot of misinformation and deceptive messaging surrounding the Fair Tax in recent weeks by those who pretend to have the interests of small business owners at heart, but here's what you need to know:

- The Fair Tax will keep taxes the same or give a tax cut to 97% of Illinoisans, only increasing taxes on those making more than \$250,000 a year. For a small business owner, that means you won't see your taxes increase unless you make more than \$250,000 in profits per year.
- If you are making more than \$250,000 a year in profits, a slight increase in taxes is a small
 price to pay for a state that better serves its residents and grows our customer bases.
- Small businesses need a stable fiscal environment to thrive. The Fair Tax will help address
 Illinois' budget deficit and put our state on the trajectory to fiscal sustainability.
- We need strong communities for our businesses to succeed. The Fair Tax will generate
 additional revenue to fund our education system and other critical programs, making our state
 a magnet for people to work, live, and raise a family.
